For the year ended 2010, the Railroad Commission of Texas reports that our bundled residential and small commercial rates are less than the rates charged by our larger competitor, CenterPoint Energy Entex. With the ability to negotiate rates with large commercial and industrial customers, we are on an even playing field with other larger utilities. Those rates may include fully bundled rates for both natural gas and transportation service to the customer's meter or, when the customer has the ability to secure its own natural gas supply, rates for transportation services only.
